A.2.a. ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)		
<p>Currently, the T013.0 (Submit Meter Details) includes a D4006 EFD as a required Data Item.</p> <p>However, the CMA recently identified an issue with this (Issue No. 13749), which recognised that none of the Data items included in the T013.0 actually require D4006 Effective From Dates, since none of the Data Items in the T013.0 are chargeable, and only the D3015 (Datalogger_SW) and the D3016 (Datalogger_NonSW) are attributed with the D4006 in the CMA CS.</p> <p>In addition to being more complicated than it need be, the requirement for the D4006 EFD in the T013.0 might be misleading, creating ambiguity as to the nature of the Data Items in the transaction. In fact, when a T013 is successfully submitted, any updated Data items are simply held in the CMA CS as non-dynamic, with audit records that identify the T013.0 submission date for the changes made (and the D4006 EFD for any values for the D3015 and D3016 are also held).</p>
